# 1934 Utah Fishing Proclamation

#### A PROCLAMATION

March 3, 1934

WHEREAS, it has become advisable to open the season to sucker snagging in the waters described herein.

NOW THEREFORE, I, Newell B. Cook, Fish and Game Commissioner of the State of Utah, by virtue of the authority vested in me by the laws of Utah, do hereby proclaim and declare that commencing Saturday March 24 and continuing until June 1, 1934, suckers may be taken by grappling hooks in that portion of the Provo River, Utah County, from U. S.. Highway No. 91, northwest of Provo City, down to Smith's Channel, as marked and posted on the ground. IN WITNESS THEREOF, I have hereunto affixed my hand and seal Salt Lake City, Utah, this 3rd day of March, A. D., 1934.

# <u>A PROCLAMATION</u>

Whereas, by reason of the present drought conditions and the early season it has been advisable to permit fishing in certain of the streams of this state prior to June 15, 1934,

NOW THEREFORE, I, Newell B. Cook, Fish and Game Commissioner of the State of Utah, by virtue of the authority vested in me by the laws of Utah, do hereby proclaim and declare that all streams of this state and Bear Lake, located in Rich County, Utah, except as herein below otherwise provided shall be opened to fishing commencing at 4 a.m. Sunday May 13, 1934. The following lakes and streams of this State shall be closed to fishing until 4 a. m. the morning of June 15, 1934, to-wit:

All Lakes in the Uintah Mountains lying above an altitude of 7,000 feet (this includes the lakes at the head of the Provo, Duchesne, Rock Creek, Uintah, Green and Bear Rivers, but does not include Moon Lake in Duchesne County);

All of the Weber River above the bridge which is located three miles west of Holladay Park, near Howell's Ranch Summit County:

All of the waters of the Smith-Morehouse above the Smith-Morehouse dam, Summit County;

All of the Provo River and its tributaries above the Soapstone Bridge, Wasatch and Summit Counties;

All of the tributaries to Beaver Creek above Kamas, Summit County;

Freemont River, Sevier County, its entire length;

7 mile creek, Sevier County, its entire length;

Johnston's Reservoir, Sevier County;

Forsyth Reservoir, Sevier County;

U. M. Creek, Sevier County, its entire length.

Huntington River and its tributaries above the point where it junctions with Bulger Creek;

Provided that the portion of Red Creek in Wasatch and Duchesne Counties lying above the point where the Victory Highway crosses said creek and all of Currant Creek in Wasatch and Duchesne Counties shall be closed to fishing until 4 a. m. the morning of July 1, 1934.

Provided that the following water shall be closed the entire year 1934:

All waters above the mouth of the narrows of the South Fork of the Ogden River, Weber County;

Temple Fork, a tributary to the Logan River, in Cache County, the entire length:

City Creek, Sale Lake County, the entire length;

Little Cottonwood, Salt Lake County, through the Murray City Park only;

That portion of Fishlake lying within a radius of 250 feet from the mouth of Twin Creek, Sevier County;

Echo Dam for a distance of one hundred and fifty feet above the dam and two hundred yards below the dam, Summit County;

Heiner Creek, Summit County, its entire length:

Midway Spring Creek its entire length, Wasatch County;

South Fork of the Provo River, commencing at the mouth of the fork at Vivian Park its entire length, Utah and Wasatch Counties;

Deer Creek, Wasatch County, a tributary to the Provo River;

That portion of the Provo River and its tributaries from the Carterville bridge north of Provo to Smith's Channel west of Provo, Utah County;

Beaver Dams on South Fork of Weber River on the Thomas Ranch, Summit County;

Beaver Dams on south side of Smith-Morehouse and at mouth of Smith-Morehouse canyon, Summit County;

Spring Creek and Fort Creek between Peoa and Weber River, Summit County;

Blue Spring Creek Garfield County, its entire length;

Ipson Creek, Garfield County, its entire length;

Provided that, "It shall be unlawful to angle for fish in the Strawberry Reservoir in Wasatch county or in any of its tributaries, except that in the Strawberry Reservoir, the Strawberry River up to the Victory Highway Bridge in Indian Creek above the diversion works and in Fish Creek and is tributaries above Pleasant Valley Reservoir in Carbon County, it shall be lawful to angle for fish between July 1 and October 20 following. In Fish Lake in Sevier County, Navajo Lake in Iron County and Blind Lake in Wayne County it shall be lawful to angle for fish only between June 15 and October 1, following."

#### A PROCLAMATION

Whereas, by reason of the present drought, it has become advisable to permit fishing in Strawberry Reservoir prior to the regular opening date set by law,

NOW THEREFORE, I, Newell B. Cook, Fish and Game Commissioner of the State of Utah, by virtue of the authority vested in me by the laws of Utah, do hereby proclaim and declare that said Strawberry Reservoir, Wasatch County, Utah, shall be open to fishing on the 15<sup>th</sup> day of June 1934, commencing at 4 a. m. All tributaries to the said Strawberry Reservoir shall be closed to fishing the entire year of 1934.

## <u>A PROCLAMATION</u>

Whereas, it has become advisable to prohibit fishing in the following waters:

NOW, THEREFORE, I Newell B. Cook, State Fish and Game Commissioner of the State of Utah, by virtue of the authority vested in me by the laws of Utah under section 30-0-7, do herby proclaim and declare that all streams in Cache County except Bear River (this does not include reservoirs on Logan River and Blacksmiths Fork), all tributaries to the Weber River in Weber, Morgan and Summit Counties except East Canyon above the dam, all tributaries to the Provo River in Utah, Wasatch and Summit Counties shall be closed to the angling of fish for the season of 1934, commencing Sept, 17, 1934, and do hereby, because of an emergency existing, declare the waters of East Canyon in Morgan County from the East Canyon Dam to the Weber River closed August 29, 1934.

## A PROCLAMATION

Whereas, it has become advisable to prohibit fishing in the following waters: NOW, THEREFORE, I Newell B. Cook, State Fish and Game Commissioner of the State of Utah, by virtue of the authority vested in me by the laws of Utah under section 30-0-7, do herby proclaim and declare that all streams, lakes, and fishing waters in the state of Utah shall be closed to the angling of fish, for the season of 1934 on October 1, 1934, except those waters under Section 30-0-32 which shall be open to the fishing of cat fish and common fish any time of the year as follows: The Jordan River, Utah Lake, the Sevier river below its junction with Clear creek near the south of Sevier canyon, the Green river below the bridge on the Victory Highway, the Duchesne river below its junction with the Strawberry river, the Bear river below the Cutler Dam, the Weber river below its junction with the Ogden river, the Minersville reservoir, the Colorado river, and the San Juan river.
