1938 FISHING PROCLAMATION

WHEREAS, it has become advisable to permit fishing in certain of the streams, lakes and reservoirs of the State of Utah prior to June 15, 1938,

NOW THEREFORF, I, Newell B. Cook, Fish and Came Commissioner of the State of Utah, by virtue of the authority vested in me by Section 30-0-7, Revised Laws of Utah 1933, do hereby proclaim and declare that all streams, lakes and reservoirs of the State of Utah below the altitude of seven thousand feet except as herein below otherwise provided shall be and are hereby proclaimed and declared opened to fishing commencing at 4 a. m. Sunday May 29, 1938; provided that any lakes, reservoirs or streams above the altitude of seven thousand feet not mentioned in the exceptions following shall open and close in accordance with Section 30-0-33, Revised Laws of Utah 1933, unless otherwise proclaimed by the Commissioner:

EXCEPTIONS

The following exceptions shall be in effect in the State of Utah during the year 1938:

BEAVER COUNTY:

Little Reservoir in Beaver County shall open to fishing on May 29, 1938, regardless of the fact that it is over 7,000 feet in elevation. Puffer Lake, High-Low Reservoir and Kent's Lake shall open to fishing on June 15, provided that Kent's Lake shall close to fishing from July 10 to September 1, due to the fact that the fish taken from this water are not edible during this

Period. The Minersville Reservoir and all streams below said reservoir shall be opened to fishing for common fish the year around. The slough, known as the Adobe Yard Slough, botween the Beaver State Fish Hatchery and the west property line of Kelly's Hatchery shall remain closed to fishing during the entire year of 1938.

BOXELDER COUNTY:

Nichols Slough, on the north side of the Brigham-Corinne Highway, about four miles west of Brigham City, shall be closed to fishing during the entire year of 1938.

GACHE COUNTY:

The following streams and reservoirs in Cache County shall be closed to fishing the entire year of 1938: Right Hand York of Logan River; Temple Fork; Beaver Fork; White Pine Creek and Logan River above the point where it junctions with Beaver Creek; the tail race at the Logan City Power Plant in Logan Canyon; Sheep Creek, from the site of Smart's Bungalow at the north of Hay's Canyon to its source; Smithfield Creek from the east Bench Diversion to its source; the southeast portion of the Hyrum Reservoir for approximately three quarters of a mile from the point where Little Bear empties into said reservoir, as marked and posted on the ground. Provided that all waters west of the Union Pacific Railroad tracks extending from the Idaho Line through Logan to the Mendon Highway and all waters north of the Mendon Highway west to the Olsen Road shell be open to fishing for common fish the year around. CARBON COUNTY:

The Scofield Reservoir in Carbon C unty and Fish Creek below the reservoir shall open to fishing on May 29, 1938, regardless of the fact that they are over 7,000 feet in elevation; provided, however, that Scofield Reservoir shall be closed for a distance of one hundred yards radius from the mouth of

oach and every tributary to raid reservoir until July 1, 1928. Provided further that all tributaries to Sporield Reservoir, except the Goosenesty CCC Fish Pend, which opens on June 15, about rumain closed to righting until July 1, 1078.

DAGGETT COUNTY:

All the strooms, lakes and reservoirs in Daggett County, regardless of altitude, shall remain closed to fishing until July 1, 1938.

PUCHESNE COUNTY:

The following streams and lakes in Ducheene County shall open to fishing on May 29, 1988, regardless of the fact that they are ever 7,000 feet in elevation:

Strawberry River Proper below the Reservoir;

Moon Lake;

The Lakes in Lake Canyon;

Duchesne River below its junction with the West Fork and the North Fork of the Duchesne up to the Old Mill Bridge above Savage's Ranch;

Rock Creck up to the Forest Bridge above Petersen's Ranch; Uintah River up to the Big Spring;

Red Creek and Current Creek below the point where the Victory Highway crosses said streams;

County lying above an altitude of 7,000 feet, and Red Croek and Current Creek above the point where the Victory Highway crosses said streams shall be closed to fishing until July 1, 1938.

EMERY COUNTY:

Boulger Creek and Huntington River above its junction with Boulger

Creek shall recain closed to fishing until July 1, 1958. GARFIELD COUNTY:

Panguitch Lake shall open to fishing on June 15, 1938.

Trapic Fescryoir and its tributaries; Ipson Crock; Blue Spring Crock; and Pine Crock, near Escalante shall remain closed during the ontire year of 1938.

JUAB COUNTY:

Burraston Pond shall remain closed until July 15, 1938.

The following tributaries to Salt Crack Canyon shall remain closed to fishing during the entire year of 1938: Birch Gwamps stream; Bradley Canyon stream; the Hop Crack Canyon stream and Pole Canyon stream.

KANE COUNT:

Nevajo Lake in Kane County shall open to fishing on June 15, 1938.

Duck Creek Spring shall be closed for the entire year of 1938.

MORGAN COUNTY:

The following streams in Morgan County shall remain closed during the entire year of 1938: Steddard Slough from the Steddard-Milton Road to its source; and Francis Creek from its junction with Lost Creek to its source.

RICH COUNTY:

Bear Lake and all of its tributaries shall open to fiching on May 29, 1938.

SALT LAKE COUNTY:

Eig Cottonwood stream above the Mill "D" South Fork and all the lakes at the head of said stream shall remain closed until July 1, 1938. Pro-vided that Mill "B" and Mill "D" South Forks, tributaries to Big Cottonwood Creek; Porter's Fork, in Mill Creek Canyon; City Creek; Mountain Doll Reservoir

and Little Cottonwood, through Murray City Park only shall remain closed the entire year.

SAMPETE COUNTY:

regardless of the fact that it is over 7,000 feet in elevation. Gooseberry CCC Fish Pend shall open to fishing on June 15; provided, however, that Gooseberry stream both below and above the CCC Pond shall remain closed to July 1. Provided further that all tributaries to the Scofield Reservoir shall remain closed until July 1, 1938. Provided further that Ferron Reservoir, Boulger Creek and Huntington River above its junction with Boulger shall remain closed until July 1. Provided that Wales Reservoir, near Morani, and the Spring Creek, immediately south of Fairview, shall remain closed the entire year.

SEVIER COUNTY:

The Fremont Reservoir and the stream below, regardless of the fact that they are over 7,000 feet in elevation shall open on May 29, 1958. Provided that Fremont River below the Johnston Reservoir for a distance of 300 yards shall remain closed for the entire year of 1938. Fishlake, Johnson Valley Reservoir and Seven Mile Creek shall open on June 15 and close at 9 p. m. on September 30, 1938. That portion of Fishlake lying within a radius of two hundred and fifty feet from the mouth of Twin Creek shall remain closed the entire season of 1938.

SUMMIT COUNTY:

Beaver Creek and its tributaries and Smith and Morehouse stream up to the dam shall be opened on May 29 regardless of the fact said streams are above 7,000 feet in elevation. Smith and Morehouse Dam and the stream above said dam shall remain closed until July 1. All of the Weber River and

until July 1. All other lekes and streams above an altitude of 7,000 feet in the Uintah Mountains in Summit County shall remain closed until July 1, 1958. The following waters in Summit County shall remain closed the entire year of 1938: Heiner Creek; the Echo Dam for a distance of two hundred and fifty yards above the intake of the spillway and from the needle valve of the dom down stream an approximate distance of 300 yards to a point where said stream joins the old river bed; the Weber River from fifty feet above the crest of the Weber-Provo Canal Diversion Dam to the first County road and bridge below the dom, an approximate distance of 200 yards.

TOCELE COUNTY:

Clover Crock for a distance of one-quarter mile down stream from the spring at the CCC camp shall be closed the entire year of 1938.

UTAH COUNTY:

The South Fork of the Provo River shall close to fishing September 30, 1933. It shall be unlawful to fish from the shores or within 200 yards of the shores of Rock Island in Etah Lake during the year of 1938.

Salem and Lehi Ponds shall open to fishing on May 29, 1938.
UINTAH COUNTY:

The Provo River and its tributaries above the bridge at the west property line of Stewart's Ranch shall remain closed to fishing until July 1. Bench Creek above the Bench Creek road; Red Creek and Current Creek, in

Wasntch County, Lying above the point where the Victory Highway crosses said streams shall be closed to fishing until July 1. That portion of Midway Spring Creek running through the Midway State Fish Hatchery property shall remain closed the entire year of 1938.

WAYNE COUNTY.

The lakes and streams above 7,000 feet in elevation on the Boulder Mountains shall open to fishing on June 15, 1938.

WEBER COUNTY:

All waters above the mouth of the narrows of the South Fork of the Ogden River and Causeur Creek and all its tributaries in Weber County shall be closed the entire year. Also the spillway at the Pine View Dam, as marked and posted, shall be closed the entire year.

PROCLAMATION.

June 4, 1938

TO WHOM IT WAY CONCERN:

whereas, it has become advisable to prohibit fishing in any of the tributaries to Strawberry Reservoir and in certain other waters appertaining thereto during the year 1958, unless otherwise proclaimed at a later date.

NOW THEREFORE, I, Newell B. Cook, Fish and Game Commissioner of the State of Utah, by virtue of the authority vested in me by Section 30-0-7, Revised Laws of Utah, do hereby proclaim and declare that all tributaries to the Strawberry Reservoir, in Wasatch County, Utah, shall remain closed to fishing for the entire year of 1938;

PROVIDED that Strawberry Reservoir, with the exception of that portion lying within a two-hundred yard radius from the mouth of the spillway and a two-hundred yard radius of the mouth of the Strawberry River, shall open to fishing in accordance with Section 30-0-33 Fish and Game Laws of Utah, at 4 a.m., July 1, 1938, The area mentioned in the exception shall remain closed the entire year and shall be marked and posted accordingly.

WHEREAS it has become advisable to extend the fishing season in the waters of Navajo Lake, Kane County, Utab,

NOW TREERFORE, 1, Newell B. Cook, Fish and Game Commissioner of the State of Utah, by virtue of the authority vested in me by Section 30-0-7, Revised Laws of Utah 1933, do hereby proclaim and declare that the waters of Navajo Lake, Kane County, Utah, shall be open to fishing from October 1, 1938 to October 31, 1938.

PROVIDED FURTHER that it has become advisable to close a portion of utah Lake to seining during the seining season from September 15, 1938 to April 1, 1939,

NOW THEREFORE, I, Newell B. Cook, Fish and Game Commissioner of the State of Utah by virtue of the authority vested in me by Section 30-0-7, Revised Laws of Utah 1933, do hereby proclaim and declare that the following described portion of Utah Lake shall be closed to seining during the seining season as prescribed in Section 30-0-43--September 15, 1938 to April 1, 1939:

Commencing at a point approximately one-quarter mile north of the mouth of the Provo River; thence in a southwesterly direction to the north point of Rock Island; thence continuing in a southwesterly direction to a point approximately one-half mile west of Big Spring, at Lincoln Beach; thence following the shore line in a north-easterly direction to Big Spring; thence following the shore line to the point of beginning.
