CHAPTER 45

S. B. No. 122. (Passed March 8, 1945. In effect May 8, 1945.) LICENSES

1943; 30F0-14, Utah Code Annotated 1943, as amended by Chapter 43, Laws of Utah, 1943; 30-0-16, Utah Code Annotated 1943, as Amended by Chapter 43, Laws of Utah, 1943; and 30-0-17, Utah Code Annotated 1943; Relating to Licenses for Hunting and Fishing and Licenses for Trapping Fur Bearers.

Be it enacted by the Legislature of the State of Utah:

Section 1. Sections Amended.

Sections 30-0-12, Utah Code Annotated 1943, 30-0-13, Utah Code Annotated 1943, as amended by Chapter 43, Laws of Utah, 1943, 30-0-14, Utah Code Annotated 1943, as amended by Chapter 43, Laws of Utah, 1943, 30-0-16, Utah Code Annotated 1943, as amended by Chapter 43, Laws of Utah, 1943, 30-0-17, Utah Code Annotated 1943, are amended to read:

30-0-1.2. License-Prohibition-Revocation-Misdemeanor.

It shall be unlawful for any person at any time to fish for any variety of fish, or shoot at, kill or trap for, or take in any manner, game animals or game birds of any kind, or any marten, mink or muskrat, without first procuring and having on his person a license as herein provided. The license year shall begin January 1 and end December 31. Every act of pursuing, hunting or killing any game animal or bird of this state without a license shall be considered a distinct and separate offense; provided that any person who is convicted of a violation of this title may have his license revoked for the remainder of such year, and provided further, that any person who violates the provisions of this section shall be guilty of a misdemeanor.

30-0-13. Qualifications of Applicants for License-Deer Tag-Fee-Permits.

Any citizen of the United States, who has resided in the state of Utah for three months immediately preceding application and who is sixteen years old, upon applying to any license agent and paying \$4, may receive a license to angle for fish and hunt for game birds and game

animals, except elk, marten, mink, mountain sheep, antelope, muskrat, buffalo, beaver and otter within this state, \$1 of the amount received from the sale of such license shall be paid into the state treasury and placed in a special fund to be expended by the fish and game commission solely for the necessary feeding, ranging and protection of game and for better range and game management. There shall be attached to such license a special deer tag which must be immediately attached by the licensee to a deer when killed by him and thereafter mailed by the licensee to the fish and game commission not later than five days after the close of the deer season unless earlier removed by a game warden at a checking station. Any citizen of the United States who is a bona fide resident of the state of Utah who is blind may angle for fish within the state by procuring a permit therefor. Any citizen of the United States who is a bona fide resident of the state of Utah and who is over 65 years of age may angle for fish and hunt for game birds and game animals except elk, marten, mink, mountain sheep, antelope, muskrat, buffalo, beaver and otter within this state by procuring a permit therefor. Such permit shall be obtained by application to any licensing agent of the fish and game department, and furnishing satisfactory proof of his age upon forms furnished by the fish and game department and by paying a fee of 10 cents therefor, which said fee shall be retained by the licensing agent.

30-0-14. License to Fish-to Whom Issued-Fee.

Any male citizen of the United States, who has resided in the state of Utah for three months preceding the application and who is 16 years old, upon applying to any license agent and upon paying \$2, may receive a license to angle for fish within this state. Any female citizen of the United States, who has resided in the state of Utah for three months preceding the application, and who is 12 years of age and upon applying to any licensed agent and upon paying \$1 may receive a license to angle for fish in this state.

30-0-16. License to Hunt Game Birds and to Fish-to Whom Issued-Fee.

Any citizen of the United States who has resided in the state of Utah for three months preceding the application and who is 12 years of age and under 16 years of age, upon applying to any license agent and paying \$1, may receive a license to hunt for game birds and to angle for fish in the state of Utah. No person under the age of 16 years shall be allowed to pursue, hunt or kill big game.

30-0-17. License to Trap-to Whom Issued-Fee.

Any citizen of the United States, who has resided in the state of Utah for three months immediately preceding application, upon applying to any license agent and paying \$5, may receive a license to trap for marten or sable, mink, racoon, and muskrat. Approved March 13, 1945.
